

COPYRIGHT AGREEMENT (IMAGES) FOR NEWS IN CONSERVATION (NIC)

- 1.  - b. I waive any right to royalties or other compensation arising out of, or related to, the use of the Images;
 - c. I waive all moral rights in respect of the use to be made of the Images under this permission to which I may now, or at any future time, be entitled under the Copyright, Designs and Patents Act 1988 or under any similar legislation from time to time in force anywhere in the world;
 - d. if anyone brings a claim against the IIC for its use of the Images in accordance with the terms of this permission, I will indemnify the IIC against all liabilities, costs, damages, losses and expenses of any kind (including any direct, indirect or consequential losses and all reasonable legal costs) incurred by the IIC as a result of or in connection to such claim;
 - e. to the fullest extent permitted by law, the IIC shall not be liable to me for any costs, expenses, losses or damages (whether direct, indirect or consequential) arising from the IIC's use of the Images in accordance with the terms of this permission; and
 - f. if the Images are the product of more than one author / creator or copyright holder, the IIC will require consent (by way of a signed copy of this permission) from each author / creator or copyright holder. As such, this permission may be signed in any number of counterparts, but all counterparts shall together be taken to constitute one and the same permission.
