

COPYRIGHT AGREEMENT (TEXT) FOR NEWS IN CONSERVATION (NIC)

The editor has accepted your written submission (hereafter referred to as 'Text') for publication in *News in Conservation (NiC)*. We need your cooperation and prompt response in the remaining publication processes.

It is your responsibility to ensure that you have permission to publish the images included in your Text, that the owners, creators and photographers of such images are correctly credited, and that the owners of works of art give permission to publish these images, and have supplied an appropriate credit line which has been included in your Text.

We request your permission to publish your Text in paper form within *NiC* and on the *IIC* website and in any other format or medium (electronic or otherwise) approved by *IIC*. Although we do not require transfer of copyright, we ask that if you later wish to publish the Text elsewhere either in whole or in part, that you <u>inform *IIC* prior to publishing and acknowledge that the Text was first published in *News in Conservation* including issue #, month and year (example: originally published in *News in Conservation* Issue 66, June 2018).</u>

If the Text is produced by more than one person it may be that no one person owns the copyright to the Text. Please mark the appropriate box at the end of this document, acknowledging yourself as either the sole author or one of multiple authors of the submitted Text. IIC will not publish any Text, in either paper or electronic format, without the consent of all authors.

To confirm acceptance of these terms please <u>complete the statement below and return both pages to IIC.</u> For this purpose, digital scans of the original signed form sent to the editor responsible for your Text are acceptable. No Text will be published unless this form has been signed and returned to the IIC office so that this agreement can be properly recorded.

I further grant permission to IIC to forward an abstract of my Text for inclusion in the bibliographic database AATA Online at its discretion and consent to AATA's terms and conditions (as amended from time to time) for the submission of abstracts.

I retain the copyright to the Text, together with the right to transfer the copyright to other parties in the future and the right to use any portion, or all the Text, In future publications as long as such use does not conflict directly with the interests of IIC and so long as I Inform IIC of my intention to publish the Text or any portion thereof elsewhere, acknowledging that the Text was first published in *News in Conservation* including issue #, month and year (example: originally published in *News in Conservation* Issue 66, June 2018).

I confirm that: (I) I am either the original author of the Text or one of the original authors of the Text; (ii) the Text is my original work and (iii) neither this agreement nor the Text infringe any intellectual property rights of a third party. I shall, on demand, indemnify and keep indemnified IIC against all claims, costs, damages, expenses, losses and liabilities suffered or incurred by IIC which result directly from a claim brought against IIC alleging that IIC's use of the Text, In accordance with this agreement, constitutes an infringement on the intellectual property rights of a third party.

If the Text is the product of several authors IIC requires the consent of all of those authors. Each author must sign a copy of this agreement. This agreement may be executed in any number of counterparts and may be exchanged by facsimile or similar electronic means of transmission. Each counterpart shall constitute an original of this agreement, but all counterparts shall together be taken to constitute one and the same instrument. This means that the agreement will only be effective if all the original authors of the text have signed a copy of the agreement.
