



**COPYRIGHT AGREEMENT  
(DIGITAL ENGAGEMENT VOLUNTEERS)  
IIC CONGRESS**

1. I hereby grant the International Institute for Conservation of Historic and Artistic Works (IIC) permission to use all copyright (and rights in the nature of copyright) existing in the graphic and written works, images, photographs, video and audio files of any kind, and text including blog entries and social media posts (referred to hereafter as 'Posts') listed in the attached Schedule (List Posts) below, to do the following acts, subject to, and in accordance with, the terms of this permission:

  - d. if anyone brings a claim against the IIC for its use of the Posts in accordance with the terms of this permission, I will indemnify the IIC against all liabilities, costs, damages, losses and expenses of any kind (including any direct, indirect or consequential losses and all reasonable legal costs) incurred by the IIC as a result of or in connection to such claim;
  - e. to the fullest extent permitted by law, the IIC shall not be liable to me for any costs, expenses, losses or damages (whether direct, indirect or consequential) arising from the IIC's use of the Posts in accordance with the terms of this permission; and
